## Support available for separated parents

Children benefit from the love and support of both parents. Something as simple as sending your child a recording of you reading their favourite bedtime story or singing a song can help close the distance between you and your

Child Support Agency General Manager, Matt Miller, said children benefit when parents treat each other with respect and can cooperate.

"This can be a tough thing to do when a relationship breaks down, but we encourage parents to do it for the kids," Mr Miller said.

"Many parents tell us that by viewing their post-separation relationship as a business-like partnership, they've been able to keep things cooperative and civil and focus on what's best for the kids."


New research conducted on behalf of the Child Support Agency shows strong, positive changes in how parents view their relationship with their former partner. About 43 per cent of those parents surveyed in August this year said they were very likely to deal with the other parent in a business-like way. This is up from 26 per cent in February 2008.

## **Building work probe**

FREDA Pefkos thought she was set for cosy retirement after selling her house and moving to a new partment at Ramsgate, until the walls began to crumble around her.

Mrs Pefkos said she spent more than \$5000 fixing the interior of her Ramsgate Road apartment. Defects included cracking walls and water leaks.

"I got an electric shock from water coming through a power socket in the kitchen", she said. "From the day I walked in I had problems".

Residents of the 10-apartment complex have been left with \$210.000 in repairs after Vero insurance rejected their claims on the building work.

In a letter to Mrs Pefkos, Vero said her claim was rejected because it could not be established that the builder whose name appears on the certificate of insurance was responsible for the defective works.

The letter said that the builder was placed into administration after the completion of the basement level and part of the first floor and that it was 'unclear from the documentation available" who completed the subsequent works.

Mrs Pefkos bought the two-bedroom apartment after the building had been completed by new builders for \$608,000 in 2002. She bought it from the company that owned the property, Sandakan Investments Pty Ltd, now deregis-

Simon Touma was a shareholder and director of Sandakan for one day but was not involved in the building work.

Mrs Pefkos signed the contract of sale with Mr Touma's brother, real estate agent Thomas Touma of Peter A Simon Real Estate, through which the company

Sandakan sold the apartments".

Simon Touma said he was not a director of the company at the time of land aquisition and future development.

"I was not aware of any building defects at the time of sale of the properties", Mr Touma said.

Similarly, estate agent Thomas Touma was not aware of any defects at the time of sale.

Development consent for the building was approved by Rockdale Council in 2000 and privately certified in 2002.

Former NSW Planning Minister Frank Sartor, the MP for Rockdale said controversial planning reforms introduced this year would lower the risk of shonky approvals whether they be construction certificates or occupation certificates.

"In human nature there is a shonk gene, and unfortunately it occassionally expresses itself in builders", he said.
