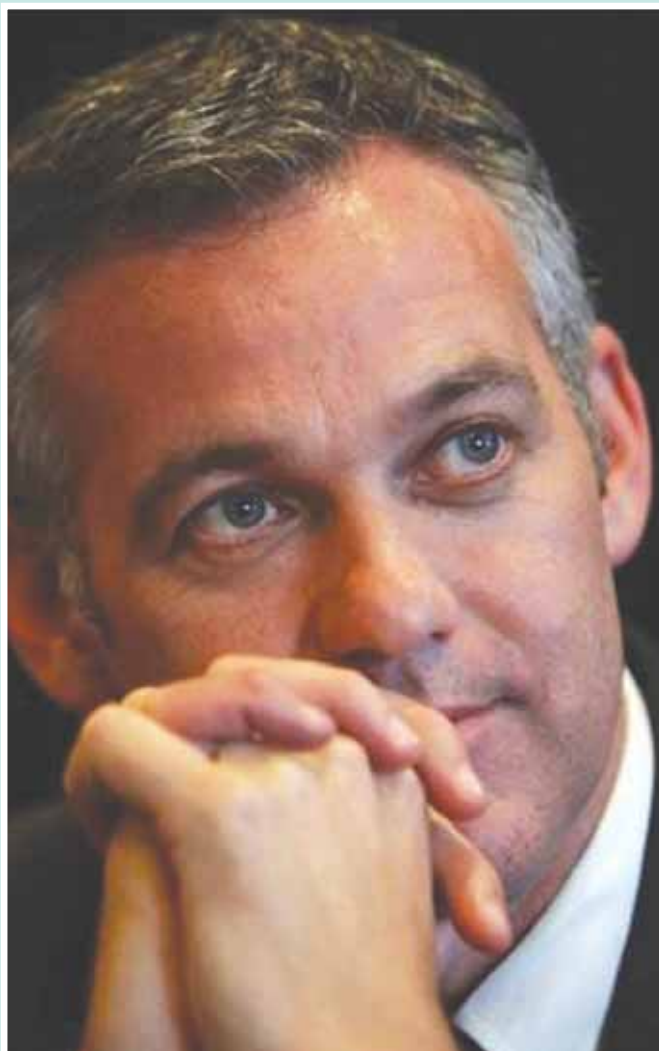

As you know, the Board of Football NSW yesterday determined to cancel the Annual General Meeting scheduled for Saturday 11 December 2010. This followed the FNSW Board's receipt of the report it had commissioned from the independent Commission of Enquiry chaired by Ron Hoening.

The Directors of FFA were also sent a copy of the report by the Commission as the report contains certain findings and recommendations regarding structural, electoral, operational and governance matters within Football NSW. The findings and recommendations have a significant bearing upon the proposed election of directors and accordingly FFA considers that the decision of the Board of FNSW to cancel the AGM to enable the report to be fully considered and addressed was the appropriate course of action.

FFA and the Board of FNSW will be convening a meeting as a matter of priority as a first step in addressing serious matters arising out of the report regarding the future direction of football in NSW including the composition of the Board and its overall operations.

This meeting will also address the importance of FFA and FNSW working together in a cooperative and consultative way and together ensuring open and transparent communication flows between our two organizations and down through to all levels of the game. We recognise that this has not always been handled well and we are committed to connecting more closely with you through FNSW. From our point of view, a strong working relationship with FNSW and its Members is absolutely vital because of the important role it and your Associations and Clubs play in the development and advancement of football in Australia.

We will ensure that you are kept regularly informed in relation to the consideration of the report.
