Love won't cost a thing

rom yesterday's Valentine's Day, d the NSW Government has waived the fee for the standard marriage certificate for one year - saving newlyweds \$45.

The Government has also waived the fee on certificates for registered relationships.

"This is a one-off Valentine's Day present," NSW Premier Kristina Keneally said.

And if re-elected, a Keneally Government will immediately begin a review of fees and charges at the Birth, Deaths and Marriage Registry - with a view to implement a revised schedule lowering or eliminating many fees which started on February 14, 2012 – the first anniversary of the plan.

Ms Keneally said this builds on the Fairness for Families Act announced earlier this month – easing cost of living pressures on new families and cutting government fees.

"This is a small gesture on behalf of the Government to share the love on Valentine's Day," Ms Keneally said.

"Waiving the marriage license fee is our pre-wedding present to the estimated 42,000 couples who will marry in NSW this year.

"I can assure anyone considering proposing this Valentine's Day that my Government is happy to cut out one minor cost – a wedding certificate.

"Every couple knows that saving for a wedding can be a challenge – everything adds up and every little bit helps."

In 2009, there were 40,564 registered marriages in NSW.

In the last six years, the number of registered marriages has risen steadily – on average by 1.82 per cent, although there is some marked variation between years. In 2006, the number of registered marriages rose by 4.3 per cent.

There are two categories of certificate: standard and commemorative. Eighty per cent of the transactions relating to marriage certificates issued are classed as "standard".

Therefore, the fee waiver does not include commemorative certificates or special urgent requests for marriage certificates. The fee waiver will only apply to marriages that occur on or after February 14, 2011 for a period of 12 months.

The fee for standard delivery of these certificates is \$45 and \$67 respectively; for urgent delivery, \$66 and \$88 respectively.

Waiving both the marriage certificate fee and the relationship certificate fee would cost about \$1.97 million a year.

O'Farrell urban sprawl to increase air pollution by six million tonnes
