## **NSW Premier League Major/ Minor Finals Week 2 Preview**

The top two sides from the NSW Premier League regular season will lock horns on Sunday afternoon at Belmore Sports Ground in their bid to secure a spot in October's grand final.

## GRANVILLE ASSOCIATION SCORES SUCCESS IN PARRAMATTA MELITA EAGLES BATTLE

LAWYERS for the Granville District Soccer Football Association believe they have gained "a significant success" in the legal battle over Melita Stadium at South Granville. The association and PCYC NSW earlier this month instigated legal action against Parramatta Melita Eagles Sports Club over a sub-lease they believe the association purchased for the ground.

he association and the sports club have run the Parramatta FC team that plays there since Granville purchased the team from the PCYC last year. However, the sports club, which has the head lease on the ground, will not issue the sub-lease. The club claims the purchase wasn't executed correctly, and could exclude them from a role in Parramatta FC. The Supreme Court last week gave orders for

the immediate use of the ground. The association's lawyer, partner Craig Powell, of Thomsons Lawyers, said he was happy with the result. "His honour's orders are a significant success for GDSFA's operations," Mr Powell told the association. "We confirm that Melita is to honour and otherwise comply with the terms of the sublease, as if it had been validly assigned to Granville and districts

soccer association. "However, we note that, as it has done so for a number of years. Melita is permitted reasonable access to Melita Stadium."The association said it needs the sub-lease as part of the criteria for Parramatta FC's participation in the NSW Premier League. However, Parramatta Melita Eagles Sports Club president James Chetcuti said the association should also honour a

participation agreement. "We still have the heritage and legacy component we have to protect," he said of the club, which has roots in the former Parramatta Melita soccer club, established in 1956. "And those terms were that we play in red and white, have the eagle on the chest and can't change the name from Melita."

The next hearing is set for October 19.
